

# SUMMARY OF THE TERMS AND CONDITIONS #SoyEcoturista PROMOTION

**Promoter: Ecotourism in Spain Association** with office address in Av. Onze de Setembre 22, 17800 Olot (Girona) and VAT number: G-85962686.

**Promotion period:** from 11<sup>th</sup> January 2023 to 15<sup>th</sup> January 2024.

**Promotion nature:** participation on this promotion is free of any charge.

**Target public:** customers of partner companies of the Ecotourism Club in Spain.

**Conditions to participate:** the promotion is open to any natural person of legal age participating according to the rules described on these terms and conditions.

**Promotion rules:** to participate on the promotion, customers of the accommodation and activity companies associated to the Ecotourism Club in Spain and collaborating with the Ecotourism Observatory have to fulfil a questionnaire after receiving an invitation code (by email or flyer). The questionnaire is available on the following link: <a href="http://es.surveymonkey.com/r/soyecoturista">http://es.surveymonkey.com/r/soyecoturista</a>. To be included on a quarterly draw, participants must complete the whole questionnaire, adding the promotional code at the beginning and a valid email address at the end. This address will be used by the Organizing Entity to communicate with the winner. There will be a new winner every four-month period whilst the promotion last.

The winner will be chosen by three draws: May 2023, September 2023 and January 2024. Each draw will include participants from the previous #SoyEcoturista promotion draw.

### Terms and conditions

- **1. Promoter: Ecotourism in Spain Association** (Organizing Entity onwards), with office address in Av. Onze de Setembre 22, 17800 Olot (Girona) and VAT number: G-85962686. This non lucrative association manages the Ecotourism Club in Spain.
- 2. Promotion length: this promotion ends on 15 th January 2024.
- 3. Target public: customers of partner companies of the Ecotourism Club in Spain.
- 4. Promotion nature: participation on this promotion is free of any charge.

#### 5. Conditions:

The promotion is open to any natural person of legal age participating according to the rules described in clause 6.

However, the Organizing entity reserves the right to refuse the participation of any person not fulfilling these terms or contravening the spirit of the promotion.

This promotion is not available for the employees of the Organizing Entity or external collaborators participating in the campaign, nor their relatives up to second grade.

#### 6. Promotion rules:

To participate in the #SoyEcoturista promotion, customers of the accommodation and activity companies adhered to the Ecotourism Club in Spain have to complete a questionnaire after receiving an invitation code (via email or flyer). The access to the questionnaire can be done using the following link: http://surveymonkey.com/r/soyecoturista. To be accepted in the raffle, the participant must complete the questionnaire totally, indicating the promotional or invitation code received at the start and a valid email address at the end. This email address will be only used to communicate the prize to the winner. If these conditions are not met, the questionnaire will not be considered valid to participate in the raffle.

Three draws will be held in May 2023, September 2023 and January 2024. One winner will be chosen every four months (quarterly) through a raffle at www.sortea2.com among all those participants who have completed the questionnaire correctly and according to the above conditions in the corresponding four-month period. Only one questionnaire will be considered for each email address.

The winner must answer within a maximum period of 72 hours after notification by the Organizing Entity. In case of not answering before the deadline time, the prize will be assigned to the next participant on the draw list.



#### 7. Prizes:
